MARTEC II opened a transnational call for collaborative research projects in different areas of maritime technologies (**deadline: 30.04.2014**). This call is initiated by funding organisations from fourteen different European partner countries of the ERA-NET MARTEC consortium.

After submission of the proposals via the MARTEC web page, the proposals will be assessed by an international expert group. Each country has own national maritime programmes and the financial support for the projects will be awarded by the national funding organisations. Priority for funding will be given for projects which include at least one independent industrial participant from each involved country. Entities like universities or research centers are very welcome as project partners. They can apply for funding as well (if supported by national regulations). Only projects, which receive funds from at least two countries, will be supported.

#### Call Handbook

The call handbook comprises detailed information on the funded research areas, the participating funding organisations, time schedule and the common regulations.

#### Full-Proposal Form

The full-proposal form has to be completed in English and requires some project information (e.g. project summary, brief project description, state of the art in R&D, technological foreseen, etc.) The full-proposal form can be downloaded from the MARTEC website. Registered project coordinators have to upload the completed form to the MARTEC website. **It has to be submitted at the latest on the 30<sup>th</sup> April 2014 (17:00 CET).**

# Einzureichendes Dokument – Full-Proposal Form

<b>1. Project objectives (max. 2 pages)</b> <ul style="list-style-type: none"><li>• Summary</li><li>• General objectives of the project (strategic, commercial, etc.)</li><li>• Scientific and/or technological aims of the project</li></ul>
<b>2. State of the art in research and development; own experiences (max. 5 pages)</b> <ul style="list-style-type: none"><li>• State of the art in research and development (including alternative solutions, Intellectual property protection rights, information search)</li><li>• Earlier research activities and experience of partners in the proposed field</li></ul>
<b>3. Working plan (max. 11 pages)</b> <ul style="list-style-type: none"><li>• Detailed working plan of the whole project (resources e.g. personnel resources)</li><li>• Workpackage description with timeline, responsibilities and parts of co-operation</li><li>• Tasks of subcontractors and third parties</li><li>• Plan of milestones/deliverables</li></ul>
<b>4. Exploitation plan (max. 5 pages)</b> <ul style="list-style-type: none"><li>• Economic advantage/expectations and potential of the project (commercialisation of results potential IPR, etc).</li><li>• Scientific and/or technical expectations</li><li>• Scientific and economic continuation</li><li>• Impact for the companies (status quo, growth, competitiveness, employment)</li><li>• Compatibility with norms, standards and regulation</li><li>• Sustainability including social and environmental impact (employment, quality of life, regional aspects, working conditions)</li></ul>
<b>5. European added value in carrying the work at European Level: (max. 1 page)</b>
<b>6. Necessity for funding and risk: (max. 1 page)</b>
<b>7. Planning aids (Gantt-Diagram, Roadmap, Resources (max. 5 pages))</b>


